AMENDMENT intended to be proposed by Mr. COBURN

Viz:

1 Strike section 901 and insert the following:

2 SEC. 901. UNDER SECRETARY OF DEFENSE FOR MANAGE-

3 MENT.

4 (a) Conversion of Position of Deputy Chief

5 Management Officer to Position of Under Sec-

6 RETARY OF DEFENSE FOR MANAGEMENT.—

7 (1) IN GENERAL.—Chapter 4 of title 10, United

8 States Code, is amended—

9 (A) by redesignating section 137a as sec-

10 tion 137b; and

1	(B) by inserting after section 137 the fol-
2	lowing new section 137a:
3	"§ 137a. Under Secretary of Defense for Management
4	"(a) Appointment.—(1) There is an Under Sec-
5	retary of Defense for Management, appointed from civilian
6	life by the President, by and with the advice and consent
7	of the Senate.
8	"(2) Any individual nominated for appointment to
9	the position of Under Secretary of Defense for Manage-
10	ment shall—
11	"(A) have served in a senior executive level po-
12	sition with operational responsibilities in a public
13	company or a Federal or State agency;
14	"(B) have demonstrated experience driving
15	strategic performance measures and leading the
16	transformational efforts of a large, complex organi-
17	zation; and
18	"(C) possess an educational background in
19	business administration, public administration.
20	"(b) Responsibility for Discharge of Cer-
21	TAIN.—(1) In addition to the responsibilities specified in
22	subsection (c), the Under Secretary of Defense for Man-
23	agement is also the following:
24	"(A) The Deputy Chief Management Officer of
25	the Department of Defense.

1	"(B) The Performance Improvement Officer of
2	the Department of Defense.
3	"(C) The Chief Information Officer of the De-
4	partment of Defense.
5	"(2) In the capacity of Chief Information Officer of
6	the Department of Defense, the Under Secretary of De-
7	fense for Management shall exercise authority, direction,
8	and control over the Information Assurance Directorate
9	of the National Security Agency.
10	"(c) General Responsibilities.—The Under Sec-
11	retary of Defense for Management is responsible, subject
12	to the authority, direction, and control of the Secretary
13	of Defense and the Deputy Secretary of Defense in the
14	role of the Deputy Secretary as Chief Management Officer
15	of the Department of Defense, for—
16	"(1) supervising the management of the busi-
17	ness operations of the Department of Defense and
18	adjudicating issues and conflicts in functional do
19	main business policies;
20	"(2) establishing business strategic planning
21	and performance management policies and the De-
22	partment of Defense Strategic Management Plan;
23	"(3) establishing business information tech-
24	nology portfolio policies and overseeing investment

1	management of that portfolio for the Department of
2	Defense; and
3	"(4) establishing end-to-end process and stand-
4	ards policies and the Business Enterprise Architec-
5	ture.
6	"(d) Precedence.—The Under Secretary of De-
7	fense for Management takes precedence in the Depart-
8	ment of Defense after the Deputy Secretary of Defense.".
9	(2) Conforming repeal of superseded au-
10	THORITY.—Section 132a of such title is repealed.
11	(3) Continuation of office.—Notwith-
12	standing subsection (a) of section 137a of title 10,
13	United States Code (as amended by paragraph (1)),
14	the individual serving in the position of Deputy
15	Chief Management Officer of the Department of De-
16	fense as of the date of the enactment of this Act
17	may serve as Under Secretary of Defense for Man-
18	agement under that section until a successor is ap-
19	pointed Under Secretary of Defense for Management
20	as specified in that subsection.
21	(b) Clarification of Order of Precedence for
22	THE PRINCIPAL DEPUTY UNDER SECRETARIES OF DE-
23	FENSE.—Subsection (d) of section 137b of such title, as
24	redesignated by subsection $(a)(1)$ of this section, is
25	amended by striking "and the Deputy Chief Management

1	Officer of the Department of Defense" and inserting "the
2	Under Secretary of Defense for Management, and the offi-
3	cials serving in the positions specified in section 131(b)(4)
4	of this title".
5	(c) Technical and Conforming Amendments.—
6	(1) In General.—Title 10, United States
7	Code, is further amended as follows:
8	(A) In section 131(b)—
9	(i) in paragraph (2), by adding at the
10	end the following new subparagraph:
11	"(F) The Under Secretary of Defense for
12	Management.";
13	(ii) by striking paragraph (3); and
14	(iii) by redesignating paragraphs (4)
15	through (8) as paragraphs (3) through (7),
16	respectively.
17	(B) In section 186—
18	(i) in subsection (a), by striking para-
19	graph (2) and inserting the following new
20	paragraph (2):
21	"(2) The Under Secretary of Defense for Man-
22	agement."; and
23	(ii) in subsection (b), by striking "the
24	Deputy Chief Management Officer of the
25	Department of Defense" and inserting

1	"the Under Secretary of Defense for
2	Management".
3	(C) In section 2222, by striking "the Dep-
4	uty Chief Management Officer of the Depart-
5	ment of Defense" each place it appears in sub-
6	sections $(e)(2)(E)$, $(d)(3)$, $(f)(1)(D)$, $(f)(1)(E)$,
7	and (f)(2)(E) and inserting "the Under Sec-
8	retary of Defense for Management".
9	(2) CLERICAL AMENDMENTS.—The table of sec-
10	tions at the beginning of chapter 4 of such title is
11	amended—
12	(A) by striking the item relating to section
13	132a; and
14	(B) by striking the item relating to section
15	137a and inserting the following new items:
	"137a. Under Secretary of Defense for Management. "137b. Principal Deputy Under Secretaries of Defense.".
16	(3) Executive schedule matters.—Section
17	5314 of title 5, United States Code, is amended by
18	striking the item relating to the Deputy Chief Man-
19	agement Office of the Department of Defense and
20	inserting the following new item:
21	"Under Secretary of Defense for Manage-
22	ment.".
