
Dear Attorney General Holder:

This responds to your letter to the Attorney General dated May 5, 2011, regarding the Fellowship Program of the National Institute of Justice (NIJ) and Grants for Developing, Testing and Demonstrating Promising New Programs (Part E) administered by the Office of Juvenile Justice and Delinquency Prevention (OJJDP). We apologize for our delay in responding to your letter.

Per your request, we have gathered and are providing the following information in the enclosed spreadsheets.

The W.E.B. DuBois Fellowship Program provides talented researchers with an opportunity, early in their careers, to elevate independently-generated research and ideas to the level of national discussion. Although the specific areas of focus vary each year, any research funded under this program is expected to have direct implications for criminal justice policy and practice in the United States. NIJ typically funds one fellow annually under this program for an amount up to \$100,000. The list of awardees for Fiscal Years (FY) 2007, 2008, 2009, and 2010 is enclosed in Enclosure 1. 
With regard to OJJDP's Developing, Testing and Demonstrating New Programs (Part E), this funding was earmarked by the Congress during FYs 2008, 2009, and 2010, and the funding went to organizations, not individuals. The organizations that received congressional earmarks out of Part E funding in FYs 2008, 2009, and 2010 are listed in Enclosure 2. In FY 2007, due to a full year Continuing Resolution (CR), this funding was awarded under the agency's discretion. The funding was also awarded to organizations, not individuals. The organizations that received funding from Part E in FY 2007 are listed in Enclosure 3.

About W.E.B. Du Bois

W.E.B. Du Bois (1868-1963) was an early leader in the struggle for racial equality in the United States. As a social scientist, Du Bois used objective methods to challenge discriminatory ideologies and institutions to advocate for social change. His classic study "The Philadelphia Negro," published in 1899, was a groundbreaking sociological study of the city's black community, and one of the first research projects to combine urban ethnography, social history, and descriptive statistics.
